(a) All the payments will be made by Cheque / Draft / Pay order in favour of " STAR CITY BUILDHOME PVT. LTD. " payable at Delhi / New Delhi.

(b) The Basic Sale Price of Apartment is Rs. \_\_\_\_\_ (per sq ft).

- (c) I/We have applied for Registration of an Unit with full knowledge of all the laws/notifications and rules applicable to this Project, which have also been explained by the Company and understood by me/us at the time of Registration/Booking.
- (d) I/We shall abide by the terms of payment as per the Payment Plan, and shall execute the Buyer's Agreement after making the mandatory payments. In case I/we fail to pay any instalment by the given due date, the Company will charge interest @ 24% per annum, compounded quarterly for the period of delay in payment. In case the outstanding dues are not cleared by me/us even after issue of repeated reminders, the Company reserves the right to cancel the Registration/booking without any intimation to me/us. In that case, I/we will not have any right or lien against the said registration.
- (e) On cancellation request from the applicant, the Company will forfeit 20% of BSP & other non-refundable amounts. Thereafter the Allottee (s) shall be left with no right, title or interest whatsoever in the said Unit.
- (f) I/We shall pay the Basic Price and other charges on the basis of "Covered Area".
- (g) The Company shall have the right to effect necessary alterations in the layout plan and decrease or increase in the size of Shop / Space up to 10%, and in such case, the payment for the increase / decrease in the Shop area shall be claimed / refunded by the Company.
- (h) The mentioned Basic Price excludes PLC, Power Backup charges, Interest free maintenance security, Registration charges or any other charges as specified in the Agreement.
- (i) That the allotment of Unit is at the sold discretion of the Company and that the Company has the right to reject any offer/application without assigning any reason. In that case, the Company will refund the Booking Amount along with interest at the rate of 8% p.a.
- (j) If there is any additional levy, rate or charge of any kind attributable to the Unit as a consequence of any order of Government / statutory or other Local Authority, if applicable, shall be payable by me/us on Pro-rata basis.
